SURFACE PREPARATION

Depending on requirements, pour in between 4% and 5% by volume to the enamel paint to which the hardener has already been added. Stir carefully before and during application.

APPLICATION

The addition of 4-5% powder by volume to the previously prepared paint generally allows two coats to be applied giving excellent performance and a pleasing appearance. Stir the paint containing the additive frequently as the granules tend to float. Always apply 2 coats. Some 3 to 5 litres of antiskid paint ready for use can be obtained using the 150 g. can.
